March 16, Noon Filing opens for party primary and convention candidates. Candidates file proper forms including Statement of Intention of Candidacy (SIC) with their county political party (7-11-15, 7-11-210, 7-11-220, 7-13-45). SIC available at www.scvotes.org

At the time of filing, one copy of the SIC is given to the candidate, and one copy is kept by the county party.

March 30, Noon Filing closes. Deadline to submit copy of the SIC to the state party along with applicable filing fees.

April 9** State party must transmit any filing fees and filing fee submission forms to the State Election Commission.
